**Club Rules for Safety and Compliance**

- 1) All guests will have firearms cased and in safe working condition prior to entering any property under the care, custody, or control of Mazonia Hunt Club.
- 2) All guests will comply with the rules and regulations as set forth by the Federal Fish and Wildlife Services and the Illinois Department of Natural Resources.
- 3) Guides will have authority while in the conduct of normal hunting practices to remove any guest acting in an unsafe manner.
- 4) All firearms will remain unloaded and in a safe position until instructed by the guide to load such firearms. After firearms are loaded with live ammunition they must be placed in the appropriate gun holder in the blind with safety engaged.
- 5) Guide will instruct hunters as to their responsibility and zone of coverage when engaged in the taking of waterfowl.
- 6) After discharging firearms they must be returned to a position of safety and placed in the appropriate gun holder.
- 7) Alcohol, drugs, or any other type of inhibitive matter is strictly prohibited prior to and during hunting on our premises.
- 8) Guests are prohibited from leaving the blind with a loaded gun in order to retrieve downed or wounded game.

**General Release**

The undersigned for and in consideration of being permitted access to and upon the premises of **THE MAZONIA HUNT CLUB** and for being permitted the use of the premises and equipment thereon, voluntarily and knowingly, executes this Release with the express intention of effecting the extinguishment of all rights, claims, actions and obligations as hereinafter designated in this Release.

The undersigned, with the intention of binding himself, his heirs, executors, administrators, next of kin, personal representatives and assigns, does hereby expressly release, discharge and covenant not to sue **THE MAZONIA HUNT CLUB**, its officers, directors, shareholders, members, and lessors of and from all claims, demands, and actions on account of injury to the person or property, or death of the undersigned.

The undersigned expressly agrees that this Release is intended to be as broad and inclusive as is permitted by the laws of the State of Illinois, and that if any portion of this Release is held invalid, it is agreed that the balance of this Release shall, notwithstanding, continue in full legal force and effect.

The undersigned further states that he has carefully read the foregoing Release, Club Rules for Safety & Compliance, and knows and understands all of its terms and executes this Release voluntarily and with full knowledge of its significance.
